



## Parent & Player Code of Conduct

As a condition of participation in our baseball program, all parents/guardians and players must agree to and abide by the following code of conduct:

1. I will encourage good sportsmanship by demonstrating positive support for all players, coaches, officials, and spectators at every game and practice.
2. I will place the emotional and physical well-being of the players ahead of any personal desire to win.
3. I will insist that my child play in a safe and healthy environment.
4. I will provide support for coaches and officials working with my child to provide a positive, enjoyable experience for all.
5. I will not engage in any kind of unsportsmanlike conduct with any official, coach, player, or parent such as booing, taunting, or using profane language or gestures.
6. I will respect the coaches and their authority during games and will never question, discuss, or confront coaches at the game field. I will take time to speak with coaches at an appropriate time and place.
7. I will demand a sports environment free from drugs or tobacco, and by consuming alcohol responsibly in permitted areas.
8. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
9. I will ensure that my child treats other players, coaches, officials, and spectators with respect regardless of race, creed, color, sex, or ability.
10. I understand that violating this Code of Conduct may result in disciplinary action including suspension or removal from the program.
11. I agree to maintain respectful and constructive communication at all times, both in person and through digital platforms such as team apps or group messaging. Any form of harassment, defamation, or inappropriate conduct directed at coaches, players, or families will result in disciplinary action, up to and including immediate removal from the team.

## Release of Liability and Assumption of Risk Agreement

### 1. Acknowledgment of Risk

I understand and acknowledge that participation in baseball, like all sports, involves inherent risks, including but not limited to: collisions, falls, being hit by a ball or bat, injuries caused by equipment or playing surfaces, weather-related risks, and travel-related risks. I voluntarily assume all such risks.

### 2. Waiver and Release

I hereby release, waive, discharge, and hold harmless the team, its coaches, volunteers, organizers, and associated facilities from any and all liability, claims, demands, actions, or causes of action for any injury, illness, damage, or loss to person or property that may result from participation in the Activities, whether caused by negligence or otherwise, to the fullest extent allowed by California law.

### 3. Medical Treatment Authorization

In the event of an emergency, I give permission for coaches or volunteers to obtain emergency medical treatment for my child and understand I will be responsible for any associated costs (this is also covered in a separate medical release form).

### 4. Behavior and Safety Commitment

I understand that all players and parents are expected to follow team rules, safety guidelines, and exhibit good sportsmanship. Failure to do so may result in removal from the team without refund of fees.
